30 Funded Hours – Three- and four-year-olds.

A further 570 hours of extended entitlement childcare are available for eligible families. The eligibility criteria for this is available on the government website. It is the parent's responsibility to check their eligibility through HMRC and they must provide us with an eligibility code for checking with the Local Authority prior to being able to take up the extended offer. Please see our admissions policy for further information.

We offer our '30 hours' as 1140 hours stretched over 48 or 38 weeks of the year.

Flexible 30 over 48 Weeks. The table below shows fees for children eligible for 1140 hours of Early Years Entitlement per annum from the term after their 3rd birthday. Funding entitlement is allocated depending on your days and pattern of attendance. Funding is allocated as 23.75 hours over 48 weeks of the year, when starting in the Autumn Term, 22.50 hours over 32 weeks when starting in the Spring Term, and 20.52 hours over the 19 weeks in the Summer Term.

15 Funded hours – three and four-year-olds.

From the term after their 3rd birthday your child is eligible for 570 hours of funded education which we offer flexibly as an enhanced stretched offer over 48 weeks of the year. We also have some places to offer for 38 weeks of funded only sessions. Our various sessions are shown in the tables below and where parents choose to access an enhanced flexible offer there is an additional charge that covers the additional services.

Flexible 15 over 48 weeks. The table below shows the fees for 15 funded hours for 3 & 4-year-olds who require additional hours to wrap around their funding across 48 weeks. Funding entitlement is allocated depending on your days and pattern of attendance. Funding is allocated as 11.88 hours over 48 weeks of the year when starting in the Autumn term. 11.25 over 32 weeks when starting in the spring term and 10.26 hours over 19 weeks when starting in the Summer term.
